Don't change your timetable on someone else's suggestion. Analyze your strengths and weaknesses. Make and follow your own timetable

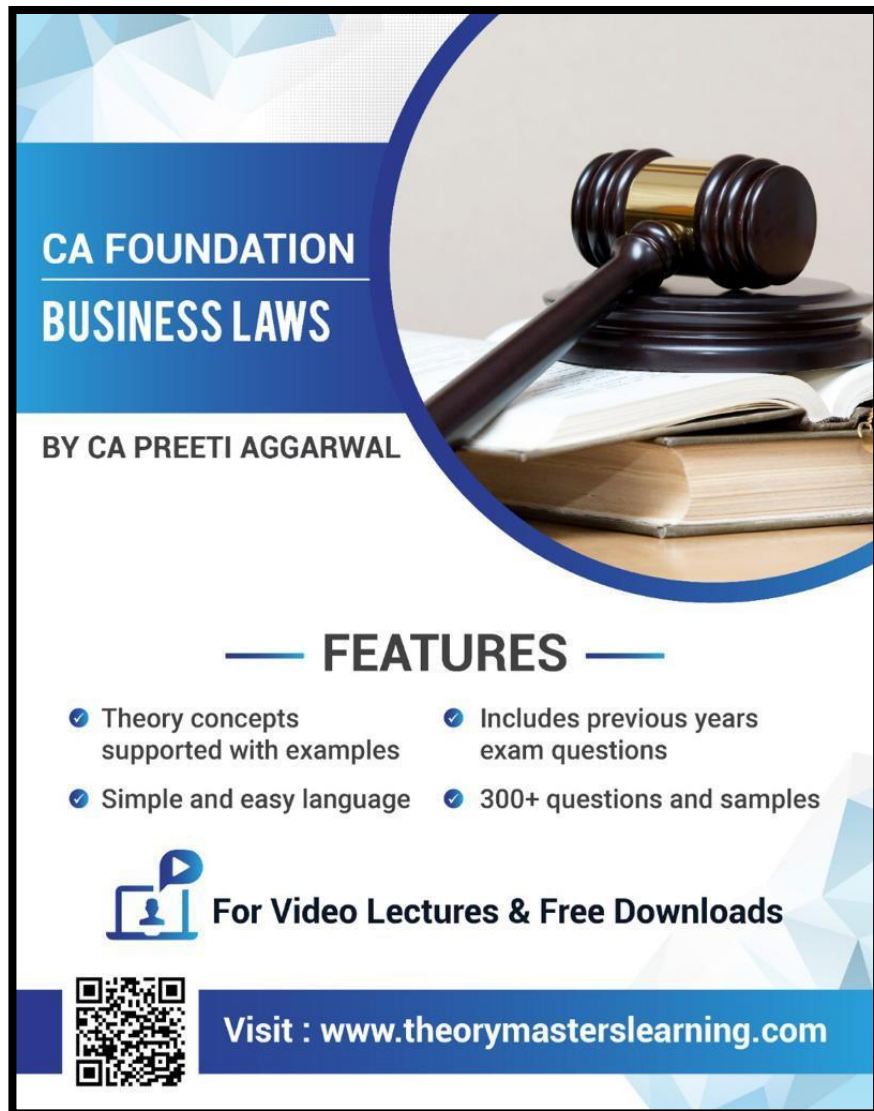
Don't be over-ambitious while making your timetable

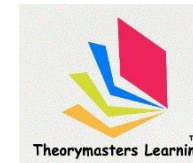
